- 1) A portion of SE 14-11-3 W in the RM of Cartier (51 Bouchard Drive, Elie, MB)



- 2) A portion of SE 14-11-3 W in the RM of Cartier (51 Bouchard Drive, Elie, MB)

as shown outlined in a heavy red line on the map attached hereto and marked as Schedule "A" of this By-law, is hereby rezoned from "RR2" Rural Residential (2 acre lots) to "RR1" Rural Residential (1 Acre Lots) Zone.

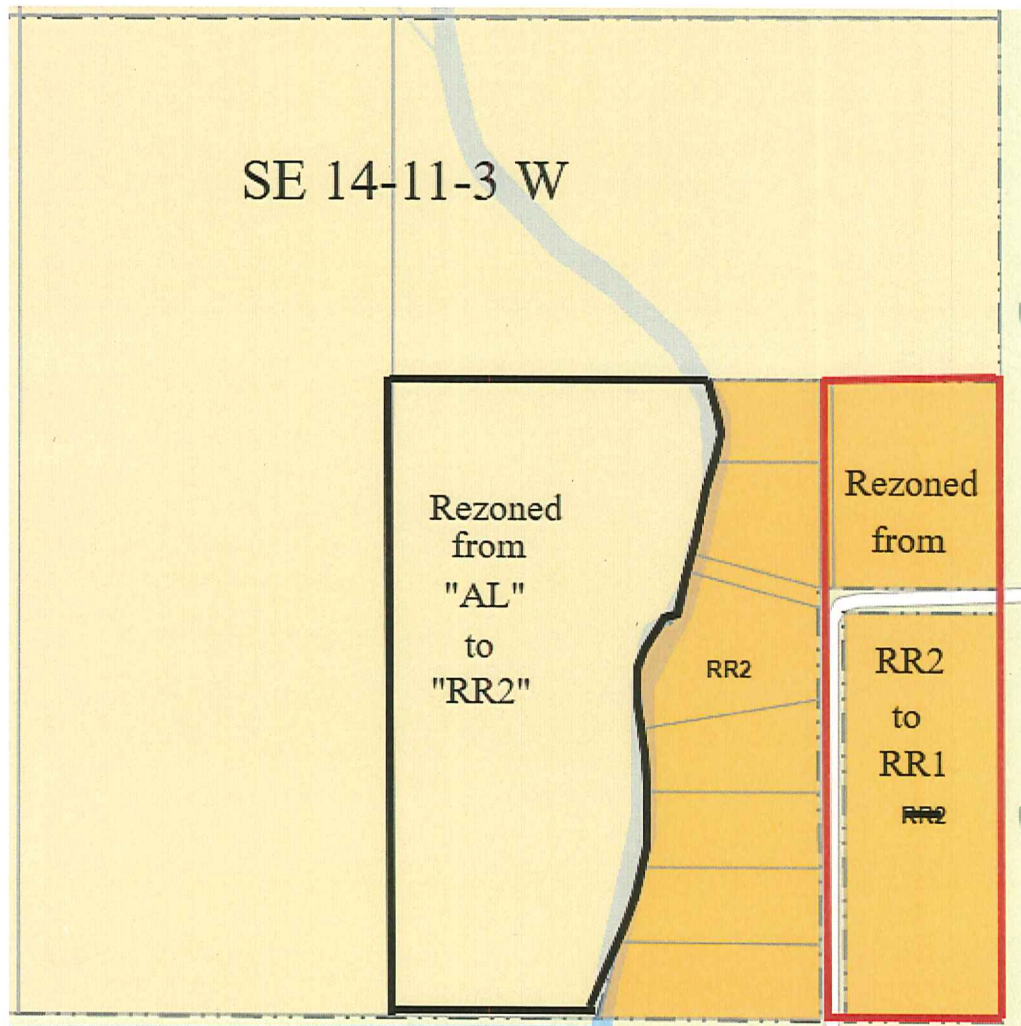
