AND WHEREAS it is deemed necessary and expedient to amend the Rural Municipality of Cartier Zoning By-Law No. 1658-18, as amended;


NOW THEREFORE, the Council of the Rural Municipality of Cartier in meeting duly assembled enacts as follows:

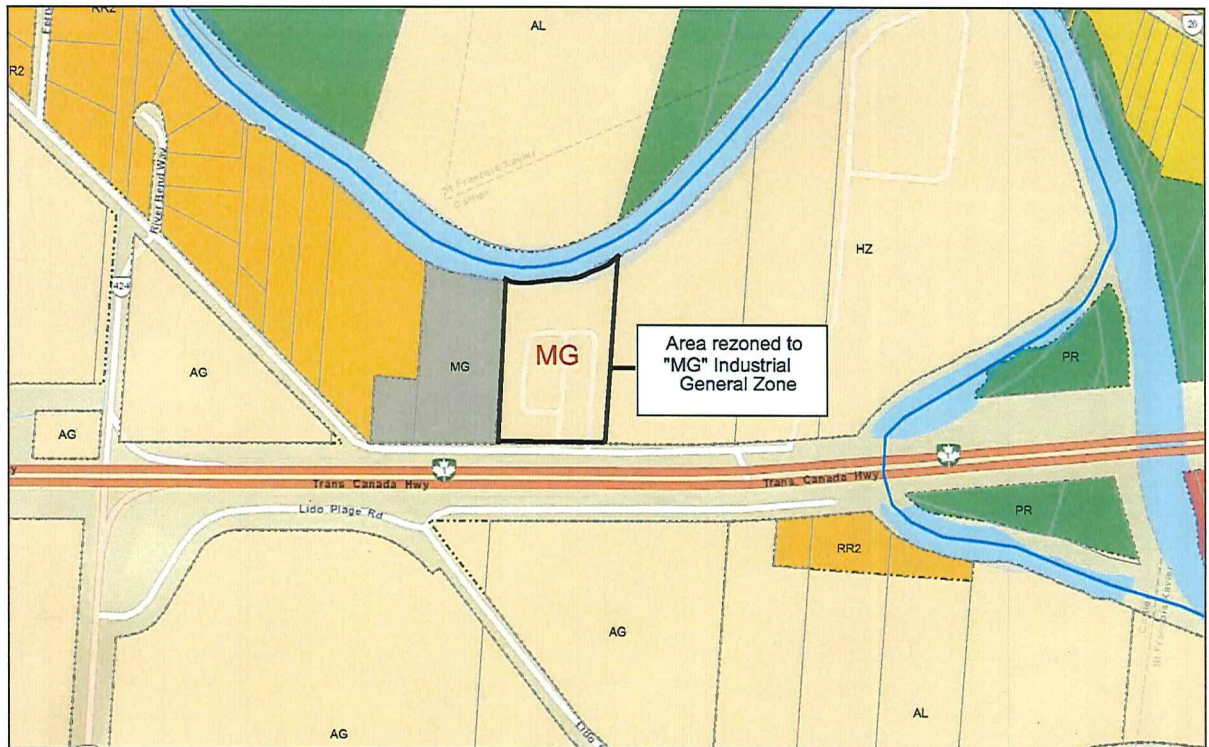
