**AND WHEREAS** it is deemed necessary and expedient to amend the Rural Municipality of Cartier Zoning By-Law No. 1658-18, as amended;


**NOW THEREFORE**, the Council of the Rural Municipality of Cartier in meeting duly assembled enacts as follows:


- 1) Survey Lot 1, Plan 14732 (7 Victoria Road), Springstein, MB. (Roll # 0032802.000)

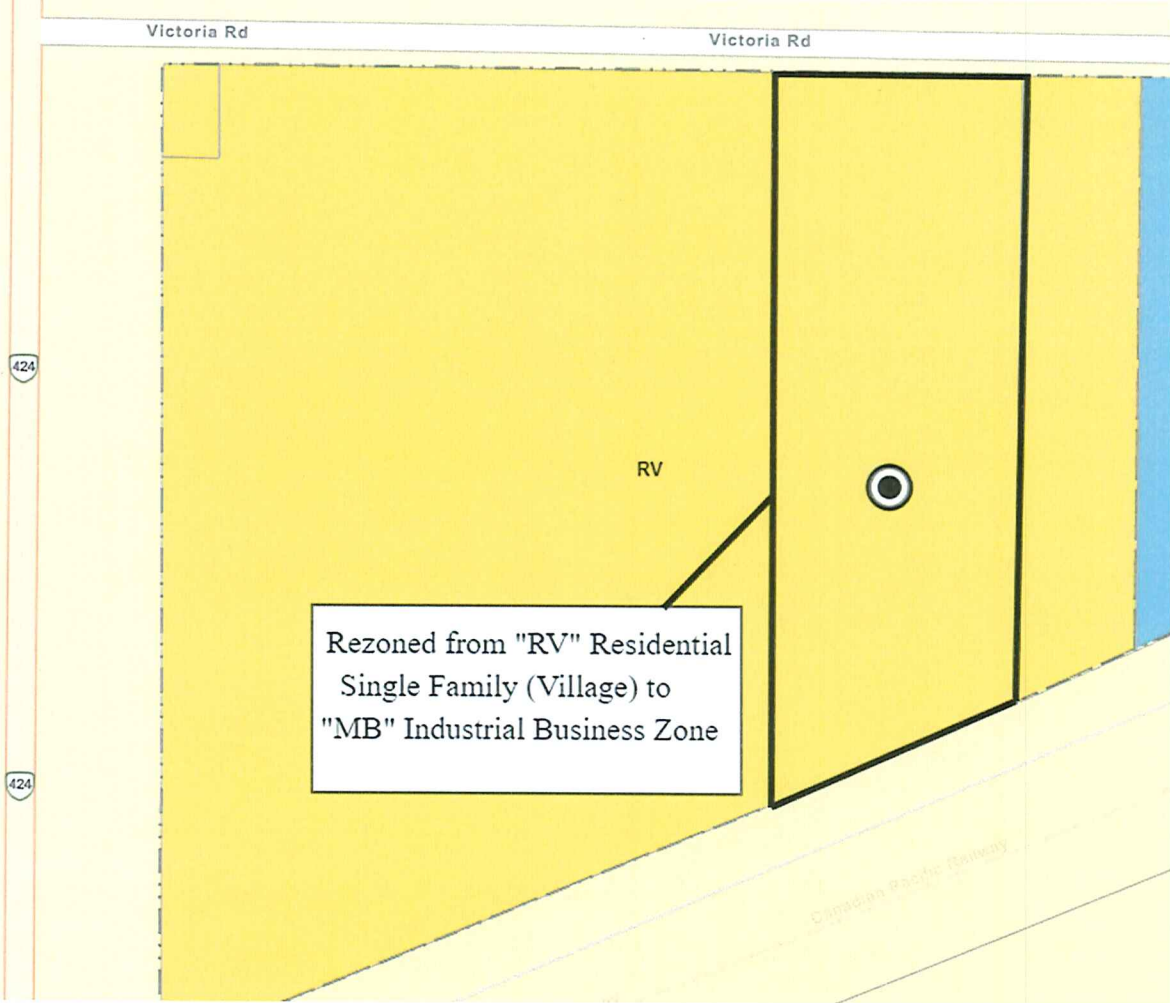
