AND WHEREAS it is deemed necessary and expedient to amend the Rural Municipality of Cartier Zoning By-Law No. 1658-18, as amended;

NOW THEREFORE, the Council of the Rural Municipality of Cartier in meeting duly assembled enacts as follows:

PART VI ZONING MAPS - MAP 3 Elie attached to and being part of the Rural Municipality of Cartier Zoning By-Law No. 1658-18, as amended is hereby further amended in order that the area described as follows:

- 1) Part of NE ¼ of Section 2-11-3 W, Elie, MB. (Roll # 0127785.000), to the West of the LaSalle River and the portion of land to be subdivided under Subdivision 4112-20-7955 (outlined with the detailed map in red shading and portion of the Subdivision Application Map);

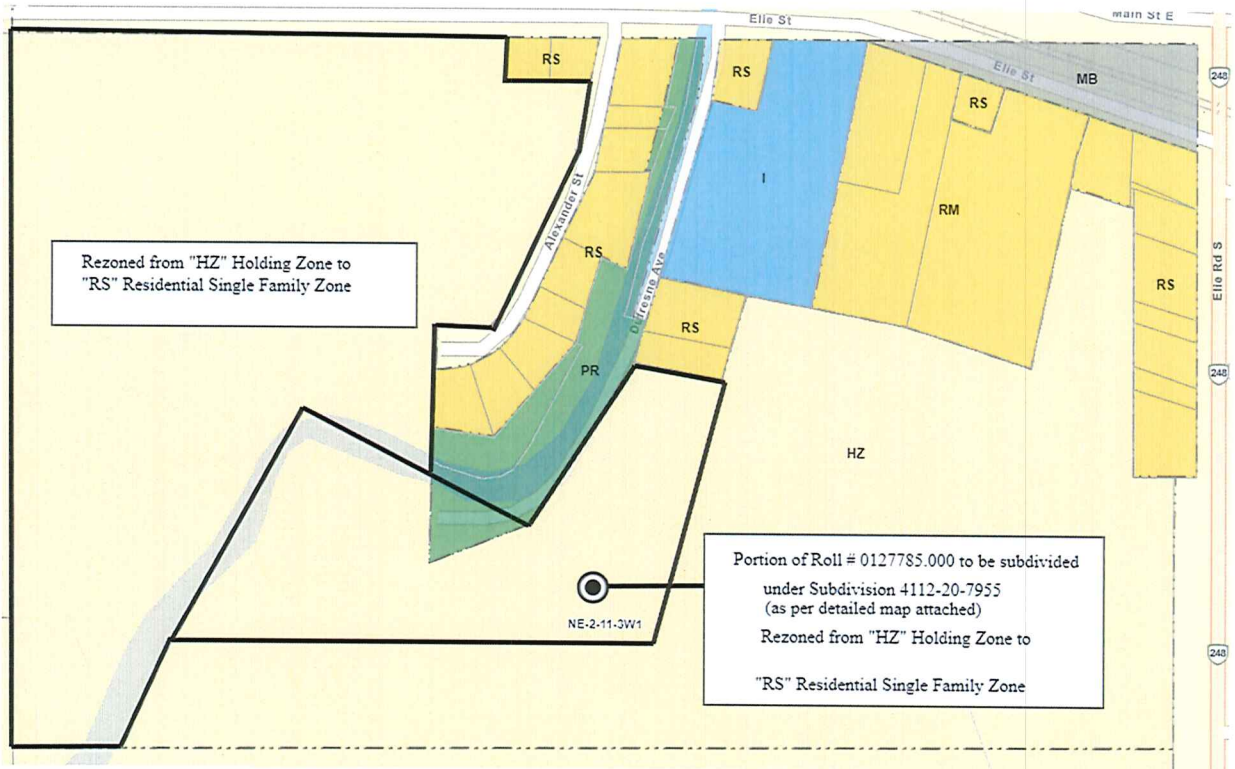

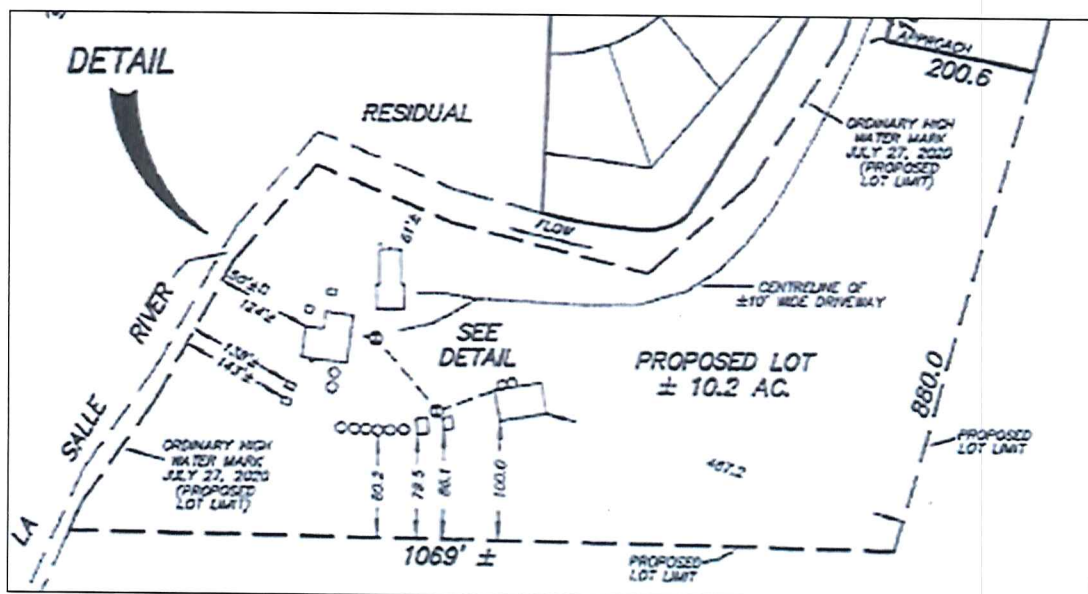
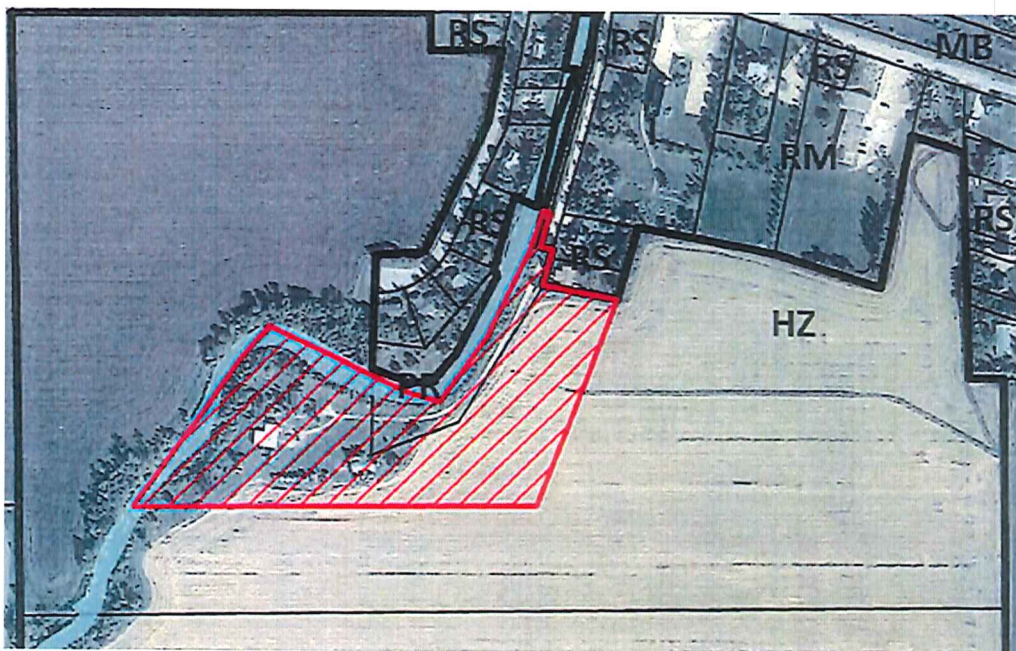
